COVER CONTAINERS AND MOVE CONTAINERS OUT OF SPILL AREA. AFTER SPILL COLLECTION, FLUSH AREA WITH WATER AND FOLLOW WITH NORMAL CLEAN-UP PROCEDURES. BE CAREFUL AS SPILLS ARE SLIPPERY.

#### 7. HANDLING AND STORAGE

**HANDLING:** FOLLOW ALL LABEL DIRECTIONS. INSTRUCT PERSONNEL ABOUT PROPER USE, HAZARDS, PRECAUTIONS, AND FIRST AID MEASURES.

AVOID INGESTION AND CONTACT WITH EYES. DO NOT TASTE OR SWALLOW.
