EYES: FLOOD WITH LUKEWARM (NOT HOT) WATER Poured FROM A LARGE GLASS 2 OR 3 INCHES FROM EYES. REMOVE CONTACTS. HAVE PATIENT BLINK AS MUCH AS POSSIBLE WHILE FLOODING THE EYES. CONTINUE FOR AT LEAST 15 MINUTES.

7. HANDLING AND STORAGE
